By signing below I am stating that I realize these hazards and hold the City of Jenks, Jenks Police Department, its officers, administrators and elected officials harmless of any fault or liability in connection to any injury, physically or mentally, that may occur while a citizen rider/participant with the Jenks Police Department.

I understand that I am an observer and will not attempt to function as a police officer or interact in any way with any operation of the department, officers or with any controls or mechanisms of the police unit. I realize I cannot be armed with a firearm even if licensed by the "Oklahoma Self Defense Act". I realize I cannot assist any officer of the Jenks Police Department while a citizen rider/participant unless directed to do so by a Jenks Police Officer.

The citizen rider/participant agrees that confidential information is considered to be confidential and proprietary to the Jenks Police Department, shall hold the same in confidence, shall not use confidential information other than for the purposes specified by the Jenks Police Department and shall not disclose any confidential information to non-Jenks Police Department Personnel.

I hereby authorize the City of Jenks to obtain from public records all data (criminal or otherwise) needed to support this application.

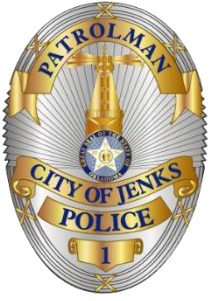

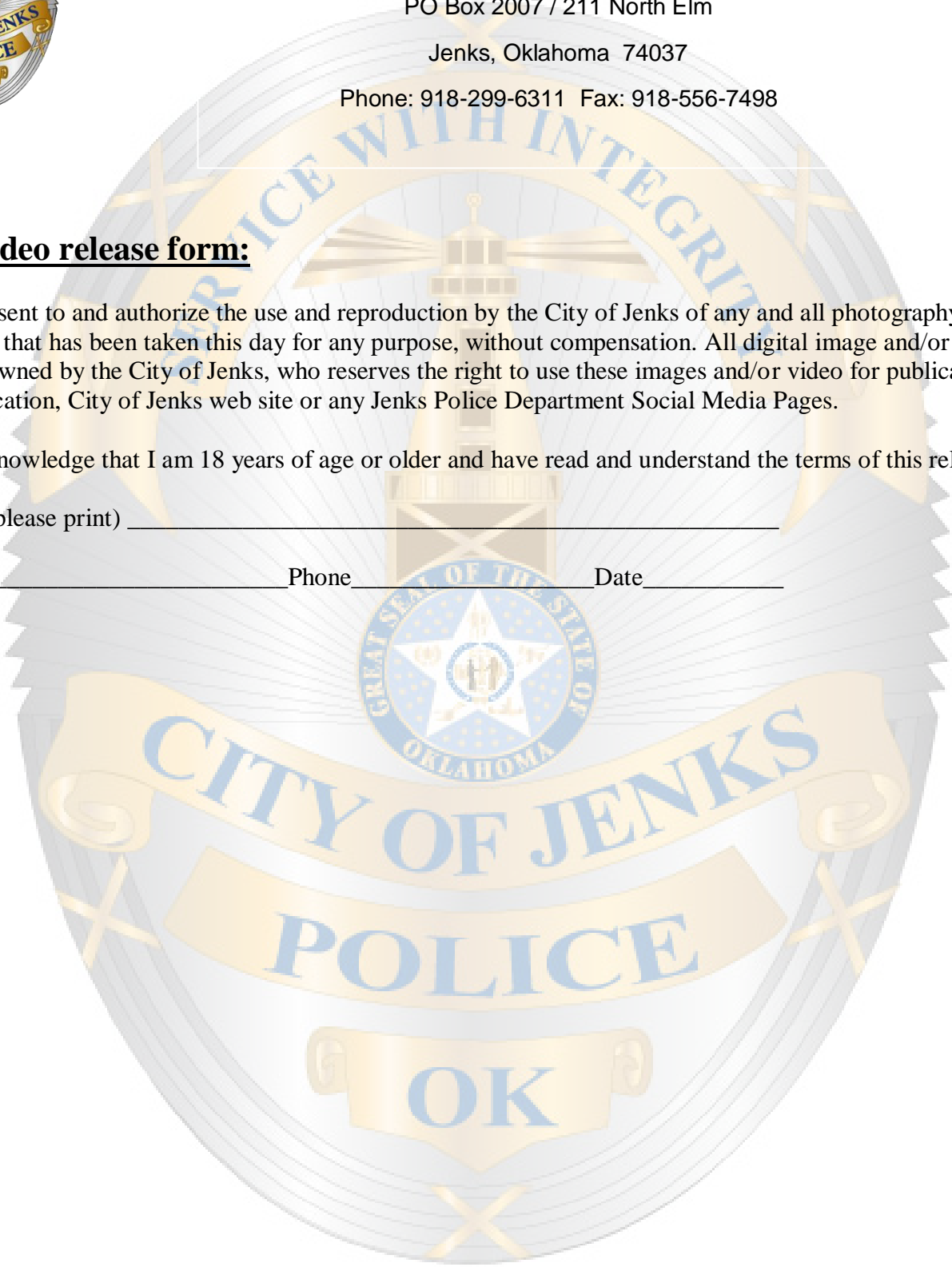
