2. **3:00 p.m. is the deadline** for applications to be RECEIVED at Jenks City Hall.
3. Applications received after **3:00 p.m.** on cutoff dates will be placed on next process cycle.
4. Application must include electronic copy in MS Word or plain text file of Legal Description of subject property, and at a minimum, a site plan illustration showing the nature of the request, surrounding streets, setbacks, building footprint, other structures, parking, circulation, and access. Application fees must be paid at time of submittal.
5. Incomplete applications will be returned to applicant noting missing information and will be placed on the schedule according to when complete application is received.

NOTE: A pre-application conference, scheduled with the Planning Assistant at (918) 299-5883, is recommended prior to finalizing applications.
